Joel K. opened with introductions and attendees shared what they are looking forward to in 2023.

Hearth Connection, Marcus Schmit, Laura Craig. www.hearthconnection.org Long Term Homeless Supportive Services Fund, (LTHSSF)

- Goal to develop relationships with the providers in the Region.
- Seven regional projects across the State of Minnesota.
- Long term homelessness defined as 4x within one year.
- They have a two-year grant for \$1,058,855 in Central Region.
- Primary goals: reduce number of people experiencing homelessness, improve housing stability, maximize
 participant choice and self-determination, reduce systemic barriers to housing and services, maximize the
 amount of mainstream funding for supportive housing.
- Isanti County is the fiscal host for the LTHSSF grant. Hearth Connection is the Intermediary. The five providers are Central MN Mental Health Center, Lakes and Pines, New Pathways, Tri-County Action Program, LSS.
- 162 individuals served in the Central Region.
- Clients can access help from the program as long or as often as needed.
- Hearth's Intermediary Role: secure, distribute, and leverage government funds for supportive housing; manage contracts, training, and monitoring of supportive housing network; co-pilot custom web-based data and rental assistance management tool; gather and analyze data for compliance, performance, and better outcomes.
- January to June 2022: 95% of households who obtained housing, maintained housing for one year or longer; 5% of households exited the program to homelessness (those 5% can re-access the program)
- Trends from the field: lack of affordable units; lack of funds to address market requirements, impact of workforce shortages, increasing behavioral health needs and the wait lists for crisis and ongoing care is long.
- Hearth Connections goal as intermediary is to simplify the programs and processes
- Capacity building: train providers on how to bring funding. Hearth Connection wants to work beyond their existing network with new and different providers. Help providers understand state and federal funding.
- Working with Wilder Research to identify system barriers, conducted interviews with people with lived experience of homelessness, conducted a provider survey.
- Simplification: more flexible provider contracts, budgets, and reporting; eliminating silos, streamline state resources, community conversations.
- Looking for out of the box simplification solutions for people in supportive housing, potential and existing providers, and for oversight agencies.

- They are offering WRAP through DOC and are considering connecting with Isanti and Chisago Counties jail programs.

Lighthouse, Amy Boldt

- They are hiring for several positions.
- Difficulty getting new providers trained.

Empower, Katrina Lussier Erickson

- Hiring for LADCs and mental health providers.
- No longer adding people to their mental health waitlist as it is over 4 months out.
- Have a two week wait for intakes for their CD OP treatment program and groups are Monday through Friday mornings 9:00-12:00N and Monday through Thursday nights 5:30-8:30pm.
