BCBS, Jennifer Jiang

- Starting May 12, 2023, counties and providers will need to have completed an Assurance Statement with DHS
 (<u>DHS-6806-ENG Telehealth Provider Assurance Statement</u>) to continue to provide services via telehealth but
 you no longer will be able to do it via **only** audio (phone). Blue Cross would not support telephone **only** contacts
 after 5/11/2023 to be consistent with DHS. They will continue to support ITV if an assurance statement is
 completed. This change is only outlined for TCM at this point, please note it includes BOTH children and adults.
 - Child Welfare Targeted Case Management (CW-TCM)
 - Children's Mental Health Targeted Case Management (CMH-TCM)
 - Adult Mental Health Targeted Case Management (AMH-TCM)
 - Vulnerable Adult/Developmental Disability Targeted Case Management (VA/DD-TCM)
