- Assisted living and memory care focused on mental health
- Two locations: Waconia and Elmore (40 min south of Mankato).
- Handle conflict behaviors, non-physical behaviors.
- Can take both over/under 55 years of age but are limited to a certain number under 55.
- Work with higher physical acuity and special diets.
- Elmore location can accommodate mechanical lifts.
- Can work with civil commitments, and Jarvis orders, and housing supports (formerly GRH).
- Elmore can take pets
- Twin Cities physicians are onsite
- Each unit comes fully furnished.
- Also work with people who have SUD history, both campuses are dry. Nagle location has an AA location they can go to. Elmore is more rural, so residents don't have the opportunity to walk to a bar or liquor store.
- Palliative and hospice care available
- Criminal records are assessed as a person. If you have a potential client, send over the information and they will review it.
- Family owned and operated, so Melissa can review with the owner.
- Openings are available because of locations, so if waiting to go back to home county, they can assist with discharge.
- In 2026 they will be opening an 88 bed location in St Cloud.
- Referrals are easy, no charge for them to assess whether the person is a fit.
- They provide free, virtual, monthly training opportunities for social work CEUs.
